MEDHA PROTSAHAN YOJNA FOR THE MERITORIOUS STUDENTS OF THE STATE

Background

- 1.1. The scheme aims to empower meritorious students of the state, by assisting them as well as those institutions working for them, towards enhancing their skills and capabilities to make them competitive for admissions in prestigious institutions. This will not only make them employable in industries, services and business sectors as well as to the government sector. It has the built-in resilience to adapt itself to the market dynamics on a continuous basis so that the target groups are not deprived of the professional acumen demanded by the changing/emerging market needs and opportunities for employment at domestic as well as international levels.
- 1.2 The scheme has been made more comprehensive keeping in view the emerging trends of employment in the era of economic reforms, liberalization and globalization.

2. OBJECTIVES

The objectives of the scheme are to assist meritorious students of Himachal Pradesh by way of special coaching for the following:

- (a) Coaching for CLAT/NEET/IIT-JEE/AIMS/AFMC/NDA etc. for qualifying examinations for admission in prestigious technical/professional institutes for course such as engineering, law, medical, management, information technology etc. and language/aptitude examinations for seeking admission to foreign universities.
- (b) Coaching for competitive examinations conducted by UPSC / SSC / Banking and Insurance, Railways and other PSUs.
- (c) Under this scheme the financial assistance to 350 students of 10+2 (Science-200, Commerce-75 & Arts 75) passed/appeared in the relevant year and 150 graduates will be given on the basis of merit.

3. IMPLEMENTING AGENCIES AND ELIGIBILITY

(a) The Department of Higher Education, Government of Himachal Pradesh shall invite the "Expression of Interest" from interested parties/organizations/ societies/companies/trusts/institutions for their empanelment under this scheme.

- (b) The following types of organizations/societies/companies/trusts/institutions will be eligible for empanelment to impart coaching for the purpose to the students of the state under this scheme:-
 - (i) All institutes in the government sector, including universities and autonomous bodies, engaged in coaching activities.
 - (ii) All the Universities/Colleges/Coaching institutes/Centres in private sector engaged in coaching activities, including deemed universities.
- 3.1 The following will be the eligibility criteria for empanelment under this scheme:
 - a) The institutes should have the required number of qualified faculty members either on its pay roll or on part-time basis.
 - b) The institutes should have necessary infrastructure such as premises, library, requisite equipment etc. to run the coaching classes.
 - c) The institutes should have experience of imparting coaching for a period not less than three years, provided that those functioning for less than three years may be considered only if their success rates are significantly higher.
 - d) Coaching institutes should have a minimum success rate of 10%. A three year moving average could be considered for this purpose. Institute having better success rate will be given priority.
 - e) Coaching institutes which are imparting coaching for entrance examinations and whose students have been able to obtain admission in reputed colleges/ institutes, will be given priority under this category.
 - f) The institutes should have a minimum 3 years experience in the relevant coaching programme.
 - g) The performance of the institutes will be evaluated after every year.
 - h) Empanelment of the coaching institute for subsequent years will depend on the level of success rate of the coaching institutes in competitive examination in previous years.
 - i) The interested parties/organizations/societies/companies/trusts/institutions has to submit the PBG (Performance Bank Guarantee) to the tune of Rs.1.00 lakh (Rupees one lakh only) as security deposit in the form of Performance Bank Guarantee pledged in favour of Department of Higher Education, Government of Himachal Pradesh in original which will be kept by the Department of Higher Education, Government of Himachal Pradesh till empanelment of institute or closure of the scheme whichever is earlier.

- j) The interested parties/organizations/societies/companies/trusts/institutions has to submit documents in support to their claims or the terms and conditions mentioned above alongwith the "Expression of Interest" in sealed cover in stipulated time period.
- k) The Audited Balance Sheets of the interested parties/organizations/societies/ companies/trusts/institutions for last three years for showing their financial strength.

4. ELIGIBILITY CRITERIA FOR CANDIDATES / STUDENTS

- i) He/she should be a bonafide resident of Himachal Pradesh.
- ii) Reservation of seats will be as per the reservation policy of state govt.
- category, 65% in respect of SC/ST/OBC/IRDP/BPL in the previous class/examination i.e. 10+1 for those appearing in 10+2 and the same criteria for those who have passed 10+2 with qualifying marks in the prescribed examination for admission into the desired course/recruitment examinations.
- iv) For graduate students they must have secured 50% marks for Gen. category and 45% marks for SC/ST category in graduation.
- v) Eligible candidates shall submit their application form to the Director of Higher Education, Himachal Pradesh who after last date of submission of application will derive the merit and select the students for grant of incentive.
- vi) Only candidates belonging to the meritorious students, having total family income from all sources not exceeding Rs.2.50 lakh per annum, double poverty line/BPL candidates will be eligible under the scheme.
- vii) Benefits of coaching under the scheme can be availed by a particular student only once, irrespective of the number of chances he/she may be entitled to in a particular competitive examination. The coaching institution will be required to take an affidavit from the student that he/she has not taken any benefit under this scheme earlier.
- Students covered under the scheme shall have to attend all classes. In the event of any student remaining absent continuously for more than 05 days, without any valid reason or leaving the coaching midway, the candidate will be debarred from any such type of assistance/scholarship/incentive from the Government of Himachal Pradesh in future

In case of the Coaching Programme for more than one month upto nine months 30% payment will be made to the student at the time of his/her registration/admission in the institute and rest 70% will be made after successful 75% attendance of the students in the concerned coaching institute on monthly basis.

The payment will be made to the students through Smart Card issued by the Government of Himachal Pradesh.

xii) 30% of the numbers sanctioned for coaching shall be earmarked for girl students/candidates. It may be transferred to boy students only in case girl students meeting the standards for coaching are not available.

5. <u>FUNDING</u>

- (i) A maximum of Rs. 1,00,000/- (Rs. One lac only) or as per actual whichever is less will be given as financial assistance to a student under this scheme once in lifetime.
- (ii) Financial Assistance will be given by the Department of Higher Education, Government of Himachal Pradesh for maintenance and expenditure on fee, books and printing material etc.

6. TERMS AND CONDITIONS TO BE COMPLIED WITH BY THE COACHING INSTITUTES FOR EMPANELMENT UNDER THIS SCHEME

- The institute shall maintain full details of name, address and telephone number etc. of the candidates enrolled for coaching programme and furnish this information to the Department of Higher Education, Government of Himachal Pradesh.
- The institute shall maintain full records of each candidate admitted under this scheme like age, gender, educational qualifications, bank account number etc.
- The coaching institution will also be required to take an affidavit from the student that they have not taken benefit earlier under this scheme or any other similar scheme funded by the Government of Himachal Pradesh.

iv) After completion of the coaching programme, the institute shall immediately submit the report of successful completion to the Department of Higher Education, Government of Himachal Pradesh.

7. GENERAL TERMS AND CONDITIONS:

- The empanelled institution/centre will not shift/transfer the students to any other associate/third party under any circumstances. If it so happens then Department of Higher Education, Government of Himachal Pradesh will impose sanctions which will include: forfeiture of the PBG and termination of the empanelment including blacklisting the institution.
- The Department of Higher Education, Government of Himachal Pradesh will all also debar such an institution/coaching centre from participating in such schemes.

8. MONITORING:

Monitoring of the progress made by the empanelled institutes will be carried out as follows:

- The institute shall submit monthly attendance, progress report of the coaching classes to Department of Higher Education, Government of Himachal Pradesh.
- The institute shall submit information of the candidates selected in various competitive examinations coached by them to Department of Higher Education, Government of Himachal Pradesh.
- The institute shall submit information of employment secured by the candidates coached by them in Government sector to Department of Higher Education, Government of Himachal Pradesh.
- iv) The grantee institute will be open to inspection by the officers of Department of Higher Education, Government of Himachal Pradesh.

9. SECURITY DEPOSIT:

- The empanelled institute has to submit the PBG (Performance Bank Gaurantee) to the tune of Rs.1.00 lakh (Rupees one lakh only) as security deposit in the form of Performance Bank Guarantee pledged in favour of Department of Higher Education, Government of Himachal Pradesh.
- ii) The Central Govt., / State Govt., Institutions / Universities / Deemed Universities/State Skill Mission are exempted from payment of Security Deposit.

10. ARBITRATION AND JURISDICTION

The Department of Higher Education, Government of Himachal Pradesh and the institution / coaching centre will make every effort to resolve any issue amicably, by direct negotiation, any disagreement or dispute arising between them under or in connection with the work order. If any dispute will arise between parties on aspects not covered by this agreement, or the rights, duties or liabilities under these except as to any matters the decision of which is specially provided for by the general or the special conditions, such dispute will be referred to arbitrator who will be the Administrative Secretary of Department of Higher Education, Government of Himachal Pradesh, will be final and binding on both the parties.

11. APPLICABLE LAW

The empanelment of institute/coaching centre shall be governed by the laws and procedures established by Department of Higher Education, Government of Himachal Pradesh, within the framework of applicable legislation and enactment made from time to time concerning such commercial dealings / processing. Any default in the terms and conditions of the document by the institution / coaching centre will lead to rejection and forfeiture of PBG.

12. EVALUATION OF "EXPRESSION OF INTEREST"

- i. The "Expression of Interest" alongwith the documents submitted for empanelment by the institution/coaching centre will be evaluated by the empanelment committee constituted by Department of Higher Education, Government of Himachal Pradesh on the basis of financial and technical capabilities.
- ii. Department of Higher Education, Government of Himachal Pradesh reserves the right to accept or reject any of the empanelment document submitted by the institution /coaching centre without assigning any reason whatsoever.
